## FROM THE PRESIDENT'S CORNER

The New Mexico Shooting Sports Association (NMSSA) Annual Meeting was held on January 24, 2004 on the New Mexico Tech Campus, and hosted by the Socorro Gun Club. If my figures are right, this was the 69th NMSSA annual meeting.

The day was filled with a variety of speakers starting with a slide projection of African and Australia Safari Hunts presented by Don and Nate Wenner. Tara Reilly-Mica (NRA/ILA) covered the New Mexico Supreme Court hearing and the decision of the Justices which stated, "Not being persuaded By Petitioner's argument, we hold that the Concealed Handgun Carry Act does not violate Article II, Section 6 of the New Mexico Constitution. Therefore, the petition for writ of mandamus is denied." Tara also mentioned that we would address some of the concerns in the current law in the next 60-day legislative session.

Other major speakers included Darren White, Bernalillo County Sheriff, Robert B. Goode, NRA Foundation Field Representative for Friends of NRA Dinners & Auctions, and R.C. Brown, Department of Public Safety. They all provided us with some good information and answered numerous questions. Tony Trennel, who is our executive officer for muzzle-loading, covered the basic information on how to get started and enjoy black powder shooting. Tony is a muzzle-loading instructor for the New Mexico Big Horn Gun Club ([www.nmbhgc.org](http://www.nmbhgc.org)).

Our luncheon speaker was Representative Don Tripp who took the time

away from the legislative session to be with us. Don Tripp is a Republican from Socorro and represents District 49, which includes Catron, Socorro and Valencia Counties. He is also a graduate of New Mexico Tech.

In 2003, we had mini board meetings & fun shoots in Roswell, Los Alamos and Las Cruces. We had rifle, pistol, shotgun and machine gun events and we would like to do the same thing in 2004. I spoke with Bill Rodolph and John Van Marter at the Annual Meeting and we decided to have our first meeting and fun shoot at the Capitan High Power Shooting Club range. The weekend will be May 1st & 2nd and the shooting will be on Sunday morning, May 2nd. There are motels and places to eat in Capitan for those who want to arrive Saturday afternoon. We will be shooting at 600 to 1000 yards, so bring your high power rifles. The club will also have some rifles that we can use. ## A CALL TO ARMS By Paul C. Lisle

### CONCEALED CARRY WHERE TO GO AND WHAT TO DO

The first step in obtaining a concealed carry license is to pick up the packet titled "New Mexico Concealed Handgun Carry Act of 2003" from either the Dept. of Public Safety (DPS) or most State Police offices. All of this information, including both the law and the DPS rules can be downloaded from [www.dps.nm.org](http://www.dps.nm.org).

The fingerprint cards cannot be downloaded and that is why it is necessary to obtain the packet. Included in this packet are the application, fingerprint cards (2 each) and two release forms. The release forms give DPS the right to obtain medical information and any other information including felonies and misdemeanors.

The application and release forms require notarization. Also required are a certified copy (provided by the state of birth) of your birth certificate and a copy of your NM Drivers License. Passports are not acceptable in lieu of a birth certificate. You do not need to provide a picture, as the DPS will use the picture that is on your NM Driver's License. You must go through 15 hours of training. As I write this there are 68 approved instructors in NM.

A list of approved instructors and their phone numbers can be downloaded from [www.dps.nm.org/did/concealed\\_instructors.htm](http://www.dps.nm.org/did/concealed_instructors.htm). Instructor cost and rules differ. Some instructors allow only factor ammunition, some charge for additional handguns, some require drawing a loaded handgun from the holster during training, etc. When you contract with an instructor, the instructor should provide you with his cost, his rules, a list of what to bring to the training and directions to the classroom and range where the training will be conducted.

If you are qualifying with a revolver, having 5 speed loaders loaded with 5 rounds each will help both you and the instructor. The same applies for semiautomatics, i.e. having two magazines loaded with 10 rounds and one magazine loaded with five rounds (or five magazines loaded with 5 rounds each) will make life easier on the range.

Upon completion of training the instructor will provide you with a certificate of training that needs to be included in your submission to DPS. DPS instructions for submission of the application need to be exactly followed or the application will be returned as incomplete. This includes paying the \$100.00 to DPS with certified (cashier's check, money order, etc.) funds. An added note for those that want to carry a small caliber handgun is that when you qualify with a 32 or larger handgun, you can also qualify with a smaller handgun, i.e., 22, 22 Mag, 25 etc., and the smaller caliber gun will be listed on your concealed carry license. After correctly submitting your application to DPS, it is taking about 4 weeks to receive the license.

As with any paper work submitted to a government agency, it is highly recommended that you make and keep a copy of your application. If after you obtain your Concealed Carry License, you acquire a handgun that is of a different type/caliber than the one on your license, you can qualify with the new gun and pay DPS a \$5.00 fee to have it added to your license. An additional benefit to Concealed Carry Licensees is that no background check is required when purchasing a handgun. However, the ATF 4473 form must still be filled out.

## HUNTING – CONSERVATION - AND OTHER STUFF

Although the present legislative session was a “short” one, a lot has been happening. There was a legislative attempt to change the definition and rules regarding “Criminal Trespass.” The changes would have been detrimental not only to sportsmen, but to anyone who likes to hike. It appears that this effort either was defeated or simply died for lack of support.

When the ATV legislation was proposed, ardent gun haters tried to restrict ATV users from carrying a loaded firearm on the ATV. Thanks to NRA (Tera Mica – Tom Arvas) and others, these provisions were defeated [with the anti-gunners and anti-hunters, we can NEVER relax]. There was a revealing comment from an anti-hunting group overheard in Santa Fe.

This group is presently opposing cock fighting. Sounds reasonable?? The comment was “once we’ve defeated cock fighting, we’ll go after the bow hunters.” Doesn’t sound reasonable to me!!

Anti-hunting groups are actively attacking hunting in Maine, New Jersey, Michigan, Minnesota, Wisconsin, Alaska and other places. Note: some of these are BIG hunting states. It can, and is, happening here. In 2002, the top six anti-hunting organizations had a cumulative program budget of over \$120 million; a fair share of which goes against hunting interests. And to combat this, the typical hunter sits on his tail and says nothing. A prominent and powerful NM legislator was told that he has about 20 thousand hunters in his district. He replied that he didn’t care because he NEVER hears from them.

Please make sure your state senator and state rep-

resentative know how you feel about hunting. The squeaky wheel...etc!! Remind them that more than a quarter million sportsmen spend over \$460 million in NM each year. This supports over 8 thousand jobs and more than \$30 million in Tax revenue.

In the conservation/environmental area: El Paso Natural Gas Co, wants to drill like mad for methane gas on the Valle Vidal. The waste by-products will virtually destroy the pristine ecological beauty and value, and the polluting plus the commotion can not fail to run off the excellent wild game herds. Call your legislator; call the governor. El Paso Co. is big, rich and powerful. They can not be stopped by wishes and casual interest. I am not an environmental purist and we do need energy sources. But there are good ways and bad ways to develop these, and I believe El Paso is not noted for the good ways. If I’m wrong, please enlighten me.

There are other significant events and changes pending. I should soon be able to ascertain what is fact and what is unfounded rumor. I will use the net if anything urgent arises.

It has become obvious that we sportsmen and we conservationists (NOT prohibitors) need to be better organized and better represented before the state government and legislature. Such things have been tried before (with occasional short-term success) but things are changing in ways that promise significant improvement in this area. More on this as it develops. Remember, gun ownership, shooting and hunting will be our rights only so long as we actively work to keep them.




